RULES FOR SECTION B- STOCKMAN'S CHALLENGE

1. All Riders must be members of **Coonalpyn & District A. & H. Society Inc.** Membership is \$10.00 & all competitors must pay normal entry fee at the gate.
Gate tickets must be presented at the horse office or an extra \$10 will be charged.
2. All horses **MUST** be PIC registered.
3. Pre entry is required by Wednesday 16th October 2019. All entries after this time (including show day) will incur a \$5 late fee. No cash out facilities are available at the show grounds.
4. Open Stockman's (Riders not eligible for the Encourage) 2. Encourage Stockman's Challenge (Riders not eligible for the Open) 3. Junior Stockman's Challenge (Riders 10 years and under 18 years) Three classes in each Challenge: DRY PATTERN, OBSTACLE COURSE & TIMETRIAL
5. Competitors must be experienced and accomplished riders with appropriately trained and fit horses capable of undertaking the conditions in each or all 3 phases of the event.
6. Competitors may enter more than one horse, but must enter all horses in the same level of competition. If entries are exceedingly high, a restriction may apply. Each additional horse will be charged the full entry fee.
7. A rider may compete on more than one horse. No other competitor may ride the same horse during the competition in the same or any other level.
8. Riders competing in the Junior Section must be at least 10 or more years – but not more than 18 years on the day of the competition.
9. Competitors choosing to enter the Encourage Section are not eligible for the Open & vice versa. Entries in this section will be at the discretion of the committee.
10. The expected dress code must be worn for the entire program and will be comprised of: • Collared shirt with sleeves (jacket and tie for Dry Pattern optional) • Approved safety helmet and footwear must be worn for all events • Moleskins, jeans or jodhpurs will be accepted.
11. All riders must wear approved helmets, ASNZ3838 or ARB HS2012, and correct riding boots.
12. The rider of any horse considered to be acting in a dangerous manner will be warned by the committee in the first instance and then be disqualified if it continues to act in a dangerous manner.
13. Stallions must be ridden and handled by an adult (over 18 yrs) and tied up with both halter and neck strap (double tied).
14. Snaffle bits only to be used – no curb chains.
15. Horses must wear a bit, no bosals or halters will be allowed.
16. No head checks, tie downs, martingales, running reins, nose bands or riding whips will be allowed.
17. The same saddle must be used for the entire three sections of the event, leg protection for horses and spurs at rider's discretion.
18. Competitors must complete the program as set by the committee.
19. No alcohol to be consumed whilst competing or prior to completion of the day's events.
20. No unrestrained dogs allowed.
21. All competitors enter at their own risk with no responsibility accepted by the organizing committee for riders, livestock or property.
22. All decisions made by the judge are final.
23. Any protests must be in writing, lodged within 15 minutes of the completion of the event, addressed to the section convenor and accompanied by a fee of \$50, which will be forfeited if the protest is deemed frivolous.
24. Entries will not be accepted with-out completion of entry forms, waivers and payment; and must include PIC #

Agricultural Societies Council of South Australia Inc and **Coonalpyn & District A. & H. Society** (together the **Suppliers**) advise that participation (including passive participation) in animal handling at an agricultural show contains elements of risk, both obvious and inherent. The handling of animals is a dangerous recreational activity as animals can act in a sudden and unpredictable way, especially when frightened or hurt.

1. By signing this waiver I acknowledge that:
 - 1.1 participation in animal handling is a recreational service for the purposes of section 139A of the **Competition and Consumer Act (Cth) 2010**, and also a recreational activity for the purposes of Section 42 of the **Fair Trading Act (1987) SA**;
 - 1.2 participation in animal handling is a hazardous activity and may result in injury, loss, damage or death to me;
 - 1.3 participation in animal handling requires certain skills and experience. I declare that I have sufficient skills and experience to be able to safely and properly participate in the events;
 - 1.4 animals can act in a sudden and unpredictable ways, especially if frightened or hurt, or if exposed to loud or unfamiliar noises;
 - 1.5 animal showing events will be held in close proximity to rides and large groups of people, and that there may be loud and unfamiliar noises which can frighten animals;
 - 1.6 if the event is held outdoors, there are risks to me as a result of the weather conditions, including either extreme hot or cold weather, rain or wind;
 - 1.7 insects or other animals may cause animals to become frightened and act in an unpredictable way;
 - 1.8 there is inherent in events involving the handling of animals the risk of suffering injury including injuries caused by animals; and
 - 1.9 I use the facilities supplied for the event entirely at my own risk, as I find them and with the prior acceptance of the risk of possible danger to me.
- 2 If I suffer injury, loss or damage (**Loss**) while participating in an animal handling event, I will not hold the Suppliers, their employees or agents legally responsible for any Loss I suffer. I will not sue the Suppliers, their employees or agents for any claims, costs, damages or liability. I agree to release the Suppliers and their employees from legal responsibility for the services I have been provided and/or activity I have participated in.
- 3 I acknowledge and agree that my participation in the event and associated activities is dangerous and may have inherent risks as a result of which personal injury (and sometimes death) may occur. I acknowledge that the event and associated activities carry with them a significant risk of physical harm. I accept and assume all such risks of personal injury or death in anyway whatsoever arising from these activities and hereby waive my individual right to sue the Suppliers for all claims I or my representatives may have for such personal injury or death against the Suppliers in any way whatsoever arising from or in connection with these activities.
- 4 At the time of participating in the event, I have not been to any degree under the influence of alcohol or illicit drugs.
- 5 I will not consume any alcohol or illicit drugs while participating in the Event and agree that such use may result in my being excluded from the Event or other events with no entitlement to any refund of money paid for entry to the Suppliers.
- 6 I agree to be bound by the rules and guidelines of the Agricultural Societies Council of South Australia Inc as varied from time to time.
