## **COONALPYN & DISTRICTS SHOW TRADE SPACE INFORMATION**

### **Rules and Regulations**

**Acceptance of your site application is at the discretion of the Coonalpyn A & H Society Inc. for a one-day (Saturday) show.** Any person wishing to have a stand or side show on the Society's grounds on the day of the show shall first apply to and obtain permission for such stand from the Trade and/or Entertainment Convenor; such permission shall not necessarily be granted. We are not registered for GST.

**Any early application could be to your advantage to get your preferred site/stall location.** However, you should be aware that your application may not necessarily be successful. Site location is at the discretion of the Trade Convenor who will endeavour to place every stall in the best location for the trade stall holder & the best position for the overall flow of displays. Any concerns are to be placed in writing.

**All trade site applicants must supply a copy of their Certificate of Currency/ insurance cover with their application.**

If you are intending to sell goods of any kind you must have public and/or product liability insurance. This insurance must be sighted before any stand can be set up. Electrical cords and equipment must show current certified testing tags which may be inspected prior to the start of the day

**Entry tickets** Stall holders can purchase tickets with this application. Stall holders or helpers without pre-purchased tickets must pay at the gate on show day. If you or your staff require a receipt for the ticket purchased at the gate this can be arranged at the secretary's office during open hours on show day. Electronic payment available. Receipts are not available at the gate.

**Gates are open to stall holders for setting up the day before the Show (Friday). On Saturday the gates open at 7:30am. All stalls must be setup by 9:30am on show day and remain onsite until 4:30pm unless by prior arrangement.** For safety reasons movement of vehicles is prohibited and arrangements need to be made at the Secretary's office before any vehicle movement outside of these times.

**Maps showing site locations** of trade sites are posted outside the secretary's office 1-2 days prior to show day. Individual maps will be emailed prior to the day if possible.

**It is the responsibility of the site holder to remove all rubbish on or about their site at the end of the day.** We ask that all site holders leave the site as they found it.

**Any person using abusive or insulting language at any official on the showgrounds during the progress of the Show,** may be legally dealt with unless a satisfactory apology is tendered in writing to the official concerned and to the satisfaction of the committee.

**The Discovery Trail** is aimed at children aged between 4 and 13, but not restricted. They purchase a bag and map and are directed around the showgrounds to the participating stallholders, usually with parents. It is an opportunity for traders to interact with larger numbers of patrons. (Gift examples, stickers, piece of fruit, small novelties, wrapped lollypop)

**Objects that are deemed a nuisance or public hazard e.g. Water pistols and cap guns are banned from the Showgrounds,** see SA Country Shows attachment.
